Recommendations and resolutions from the special technical meeting in Beijing (China) between 8 and 12 August 2005

Note: These recommendations are circulated for information to the members of the Special Working Group (SWG). They will however be an integral part of the final report.

Recommendation 1a

As per the Resolution taken at the 2005-05-17 meeting held in Geneva (attached in the Annex), the meeting recommends ISO/IEC JTC 1/SC 6 to appoint an *ad hoc* working group to develop¹ a proposal which harmonizes the WAPI proposal (Part 1 of N 16) and IEEE 802.11i into one security amendment to ISO/IEC 8802-11:2005.

Positions² on Rec. 1a:

SAC: did not wish to express an opinion at this stage

IEEE: reject ANSI: reject KATS: abstain

Recommendation 1b

The meeting recommends

- 1. ISO/IEC JTC 1/SC 6 appoint an *Ad hoc* Working Group (AHWG) to develop an outline and timetable for integration of elements of the WAPI technology and 802.11i into ISO/IEC 8802-11.
- 2. The AHWG formally liaise with IEEE 802 to ensure the outline represents a feasible way to integrate WAPI technology and 802.11i into 8802-11 and IEEE Standard 802.11.
- 3. The work defined by the outline and schedule for integration of WAPI technology and 802.11 into ISO/IEC 8802-11 and IEEE Standard 802.11 be executed in appropriate WGs within ISO/IEC JTC 1/SC 6 and IEEE 802, as agreed jointly by JTC 1/SC 6 and IEEE 802.
- 4. A very close liaison be established to track and review the work as it develops in JTC 1/SC 6 and IEEE 802 to ensure compatibility is maintained with existing and developing ISO/IEC 8802-11 and 802.11 amendments.
- 5. As long as progress continues, ISO/IEC JTC 1 delay resumption of the 802.11i fast track ballot and not consider any other security related amendments to 8802-11.

Positions on Rec. 1b:

IEEE: accept SAC: reject ANSI: reject KATS: abstain

¹ Note that SAC will submit the whole of WAPI to be harmonized and standardized as a complete module in ISO/IEC 8802-11. It takes the position that WAPI and 802.11i are to be alternative security solutions within 8802-11, and that this work can be done in three months. It also has as ultimate goal the harmonization of the two proposals.

IEEE takes the position that full harmonization between the two proposals (WAPI and 802.11i) is the goal, and that the resulting draft amendment be limited to Layer 1 and Layer 2 specifications.

² Note that the "Positions" given are not votes, but are indications to convey information to ISO/IEC JTC 1/SC 6 for its consideration.

Recommendation 2

The special group (created in the resolution taken at the meeting on ISO/IEC SWG, Wireless LAN Security, Geneva, 17 May 2005) resolves that while special and unique circumstances were created to address this unusual situation, National Bodies are entitled to have transparent and unencumbered access to the ISO/IEC JTC 1 process. The special group requests that ISO and IEC ensure the return to the long established and proven ISO/IEC JTC 1 Directives to further handle JTC 1 business.

Recommendation 3

The special group (created in the resolution taken at the meeting on ISO/IEC SWG, Wireless LAN Security, Geneva, 17 May 2005) requests that ITTF, the ISO/IEC JTC 1 Chairman and the JTC 1 Secretariat actively serve to guide both the Chinese NB and IEEE on the JTC 1 procedures and ensure that any questions or concerns are addressed in a manner that allows fair and prompt processing of any document submissions.
