China NB'S final comment in SC6 Orlando meeting, Nov. 9,2004

Due to the unexpected situation that all four experts can not attend this meeting because of the visa problem that there are confusion and controversies surrounding N7506 and N7537, and that because the Chinese NB cannot enter technical discussions on this matter in this meeting, it is resolved that:

this meeting will not open a discussion on these proposals, that they are to be made agenda items for next meeting to be organized by the convener of WG1 and the chairman of SC6. All interested parties may participate. The time and place of this meeting should be decided by the organizers.

China NB also noticed IEEE 802 delegations' preposition that "N7506 and N7537 are not mutually exclusive. Both can reside within [ISO/IEC] 8802-11 as security mechanisms and be invoked when and where needed". (see note A) China NB believes that this is a new and constructive proposal and may be a way to solve the differences between the two proposals. China NB will study this concept and prepare a formal response as soon as possible.

Considering the fact that there are two amendments(N7506 and N7537) pending to deal with the security in ISO/IEC DIS 8802-11,China NB no longer opposes its publication and we accept the modified Proposed Disposition of Comments Report on Fast Track Ballot(ISO/IEC DIS 8802-11) by projector editor with the understanding that ISO amendments are open for comments, that the approval process is within ISO/IEC, independent of other organizations.
